About the survey

There are many salary surveys on the market for the legal professionals, but so far none has focused on in-house lawyer compensation in tech companies across several countries.

This survey aims to fill in this gap and to provide reliable data to both hiring managers and to individuals making decisions about their career steps.

Confidential and anonymous compensation data was gathered from over 700 in-house lawyers who took part in the survey. Data is reported in categories where more than ten responses were collected.

Roles covered

In this report we provide the detailed compensation data we collected for the full range of in-house lawyer roles:

- Legal Counsel
- Senior Legal Counsel
- Head of Legal
- Legal Director
- Deputy or Associate General Counsel
- General Counsel

Respondents include:

- in-house lawyers working in technology companies
- technology lawyers working in other sectors (for example, in such related industries as telecommunications, media and advertising, fintech, payments and professional services).

Countries covered

The report provides compensation data for the following countries:

- United Kingdom
- France
- Germany
- Spain

Whilst lawyers from other European countries have participated, the required responses threshold for reliable reporting was achieved only for these four countries. We aim to cover more countries in Europe in our next year's survey.

Future scope

As this is the first survey of its kind, one of our goals was to secure as many responses as possible. To achieve that, we tried to keep the number of questions to a minimum to ensure high participation.


In the future we aim to broaden the spectrum of data to better understand the scope of the benefits and working models provided by tech companies to their in-house legal teams.




Respondents by location




Respondents by company size



UK Observations

London and Thames Valley

London and Thames Valley base salaries are grouped together as they appear quite uniform. When we discuss London vs regional compensation, it is implied that London compensation includes Thames Valley compensation.

*'Regional' vs 'London' salaries outside of London

With many tech companies being remote first, regional compensation packages tend to fall into two categories: 'regional' packages and London level packages.

Our observations are that about 85% of in-house lawyers outside of London and Thames Valley are on regional packages (i.e. traditionally lower compared to London).

However about 15% are on London packages, typically working fully remotely or with a minimum amount of travel to London.

Based on our conversations, these 15% of in-house lawyers often transitioned into roles with London-level compensation because they had an ideal profile for the job vacancies. For example:

- They came from a competitor or from a company with a similar profile (e.g. a SaaS company lawyer moving to another SaaS company)
- They moved from private practice having specialised in an area highly relevant to the employer's business (e.g. an IT Outsourcing company hiring an associate from Tech and Outsourcing team of a large law firm)
- Senior in-house lawyers (HoL, Director, Deputy GC, GC) with relevant in-house experience often manage to retain their London-level packages when they move out of London.

Scotland, Wales, Northern Ireland






Spain Demographics


Respondents by location




Respondents by company size










Respondents by location




Respondents by company size








Germany Demographics


Respondents by job title


